

What is a School Foundation ?

The Internal Revenue Service (IRS) views education foundations as tax-exempt organizations under section 501 (c)(3) of the Internal Revenue Code. State laws must be investigated before forming a foundation and foundations should not start fundraising until tax exempt status is granted both for the foundation and its donors.

Some school foundations are set up to exclusively fund scholarships for students attending college or trade programs after graduation. The new wave of school foundations are being designed to support innovative programming and capital improvements that are not traditionally funded through school tax dollars. Recently, some foundations are granting districts monies to create and sustain professional positions.

Will The Homer Education Foundation Affect Other HCSD Fundraising Groups ?

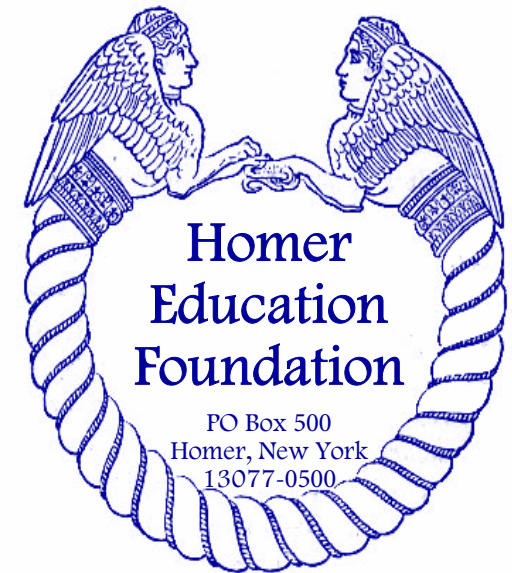

Homer Education Foundation's Current Funding Priorities

Mini-Grant Program

The Homer Education Foundation Mini-Grant Program is designed to encourage, facilitate, recognize and reward innovative and creative instructional approaches that will lead to the accomplishment of meeting curriculum goals and the New York State Learning Standards. Any teacher or guidance counselor who is involved in the direct instruction of students, currently employed by the Homer Central School District, is eligible. The number of awards will depend on funds available from the Homer Education Foundation.

Student Scholarships for Horizons Summer Enrichment Program

The Homer Education Foundation will make available student scholarships for the Horizons Summer Enrichment Program. Students who are unable to meet the financial requirement for attending the Horizons Program, may apply to the Foundation for partial or full scholarships. Scholarships will be provided to students based on need and will depend on funds available from the Homer Education Foundation.

Student Scholarships & Recognition

The Homer Education Foundation will look to secure funds so that they may provide ALL students of the Homer Central School District with available resources which will support the continuation of their education and career development. The funds will also be used to recognize students' outstanding academic or career development accomplishments and achievements.

Who Will Lead The Foundation ?

The Homer Education Foundation will be guided by a group of Volunteer Trustees, all community members, dedicated to educational enhancement and enrichment of students and staff within the Homer CSD community.

Expectations Of Trustees

- ◆ Trustees will be asked to serve terms of one to three years. A Trustee shall serve no more than two consecutive terms.
- ◆ Trustees will be expected to attend regular meetings of the Board that shall be held quarterly at a time and place to be determined by the Board.
- ◆ Trustees will recruit volunteers to sit on committees in order to carry out the mission of the foundation.
